Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and run at the end of their class/trial. This may require a bitch in season to be crated outside within a vehicle. Entry fees for bitches that come into season will be refunded if you wish to withdraw. If bringing a bitch in season, please inform the trial committee prior to the trial and all exhibitors at the judge's briefing.

In the event of extreme bad weather, the trial will be canceled and full refund made. Please note, that this is "extreme" bad weather, and weather applies to the trial site only.
