Turn right on Bloserville Rd, follow approx 3 miles. Cross over Enioia Rd, PA 944, remain on Bloserville Rd ½ mile. Turn left on Lonesome Rd. Training Facility is on left hand side of road and is marked with a Dandy Dog Training Sign. Approximately 10 miles from Carlisle, PA

**RUNNING ORDER:** Dogs will be run in height order with dogs being handled by the same person separated into different staged groups. Every reasonable effort will be made to accommodate those dogs with event conflicts, however, the handler does have responsibility

Friday night, 5:00 Ring 1- Masters- Byers (two trials)  
Ring 2 - Crazy Eights-Boyd (two trials)  
Limited to 20 master runs per trial

Saturday, Ring 1- Boyd: Instinct (offered once) begins at 8:30 AM, followed by Novice, Trial 1 and 2, then Open Trial 1 and 2, Senior 1 and 2  
Ring 2 –Brinley: will not begin before 9:00 AM with Crazy Eights followed by Masters 1 and 2.

Sunday , Ring 1- Graham: Instinct (offered once) begins at 8:30 AM, followed by Novice, Trial 1 and 2, then Open Trial 1 and 2, Senior 1 and 2  
Ring 2 –Boyd: will not begin before 9:00 AM with Crazy Eights followed by Masters 1 and 2.

We reserve the right to change class order based on entry. Any Judge of Record at this Event may be used as a Load Balancing Judge in any ring. Judge of Record and Event Official dogs may be judged prior to Event start or as the first dogs of the Event. Late and/or Day of Show entries are not a guaranteed entry and will be accepted only up to Judging limits. Confirmations will not be sent for Late entries.

These trials will be held inside under a roof, with climate control. Tarpred Agreflex flooring. There is crating space available inside the building in a separate area. Please bring a tarp to place under a crate to help protect the training room floors.

Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and run at the end of their class/trial. This may require a bitch in season to be crated outside within a vehicle. Entry fees for bitches that come into season will be refunded if you wish to withdraw. If bringing a bitch in season, please inform the trial committee prior to the trial and all exhibitors at the judge's briefing.

Early entry closes July 19<sup>th</sup>, 2019
