RUNNING ORDER: Dogs will be run in height order with dogs being handled by the same person separated into different staged groups. Every reasonable effort will be made to accommodate those dogs with event conflicts, however, the handler does have responsibility

Friday, 12:00PM Masters (two Trials) and Crazy eights in both Ring 1 and 2.

Limited to 20 master runs per trial

Saturday and Sunday, Ring 1:
Instinct (offered once) begins at 8:30 AM, followed by Novice, Trial 1 and 2, then Open Trial 1 and 2, Senior 1 and 2
Ring 2 will not begin before 9:00 AM with Crazy Eights followed by Masters 1 and 2.

We reserve the right to rearrange classes based on entries.

Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and run at the end of their class/trial. This may require a bitch in season to be crated outside within a vehicle. Entry fees for bitches that come into season will be refunded if you wish to withdraw. If bringing a bitch in season, please inform the trial committee prior to the trial and all exhibitors at the judge's briefing.

AWARDS: Placement ribbons will be awarded for first through fourth place in Novice, Open, Senior & Master classes in each height division. Ribbons will be awarded for all qualifiers in the regular classes and the Instinct Test. New Title Rosettes will be available for Novice, Open Senior & Master Titles. Flat New Title Ribbons are available for the Instinct Class
