**DAY OF SHOW ENTRIES:** We will accept day of show entries provided the trial has not filled. The day of show entry fee is \$15.00 each run with no package deals. Day of Show entries will only be taken during checkin. It is recommended that you e-mail [lmsphd@gmail.com](mailto:lmsphd@gmail.com) the week before the trial to see if we have room for Day of Show Entries.

**IMPORTANT INFORMATION: Confirmations will be sent PRIOR to July 26. If you do not get a confirmation, e-mail [lmsphd@gmail.com](mailto:lmsphd@gmail.com) BEFORE July 29. I will not check my email or phone messages after August 3. DO NOT COME TO THE TRIAL and tell me you did not get a confirmation. I will reply to EVERY email. If you send in changes, you will receive a new confirmation. If you do not get it, e-mail me.**

**ENTRY DATA:** There is no need to overnight entries. We reserve the right to refuse any entry. Anyone who is not currently in good standing with NADAC will not be allowed entry into the trial.

There shall be no refunds for entries withdrawn in the event a dog and/or handler is dismissed from competition, regardless of the reason for such dismissal. Refunds are allowed if requested before the closing date. Refunds after the closing date will be honored only for bitches in season. A \$10.00 processing fee per dog will be assessed for ANY refund. No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, weather, acts of God, public emergency, an act of a public enemy, or any other cause beyond our control.

Accepted entries may be changed prior to August 2 at 9:00 p.m. E-mail change requests to [lmsphd@gmail.com](mailto:lmsphd@gmail.com). No changes will be made at the trial, so please read your confirmations carefully. If you have questions, e-mail. Move-ups during the trial do not constitute an entry change and will be happily accommodated!

Multiple **e-mail** confirmations will be sent; at a minimum, a preliminary confirmation will be sent when your entry is received and processed and a final confirmation will be sent just prior to the trial. **Exhibitors, through submission of entry, acknowledge that they are knowledgeable of NADAC rules and regulations, and agree to abide by all rules in effect at the time of this trial.** A copy of the current Exhibitors Handbook may be downloaded free from the NADAC web site: [www.nadac.com](http://www.nadac.com)

**VETERAN HANDLER:** Handlers aged 60 years or older or disabled handlers may opt to enter Hoopers, Touch N Go, Tunnelers, and/or Weavers as a Veteran Handler which allows you to receive 10% more standard course time. This division is for Veteran Handlers only. The Veteran/Disabled Handler division is designed for handlers who, due to age or impairment, are mobility limited and need extra time to guide their canine partners through an agility course. When entering as a Veteran/Disabled Handler, you must enter all dogs in all classes for the entire trial in this Division and must jump 4" lower than your, Standard Division jump height. In the non-jumping classes, dogs will be scored and placed with their Standard Division jump height.

**SKILLED CATEGORY:** As of January 1, 2009 when entering the Skilled Category, all dogs must jump 4" lower than their Proficient, Standard Division jump height requires.

**AWARDS:** First through fourth place ribbons will be awarded for each jump height in all categories, levels, and classes (except Chances which has no placements). Qualifying ribbons will be awarded for any qualifying score.

**IMPORTANT!** Please check your dog's NADAC registration number on your trial confirmation as soon as you receive it; also, please check the copy of the results posted at the trial. You should report any errors to the Trial Secretary immediately.

NADAC records trial results as they are submitted by the host clubs/groups. The individual trial results submitted by the club are uploaded to the files section of the NADACAgility@yahoo.com list within two weeks after the NADAC office receives them from the club. The trial results will remain on the list for at least thirty (30) days. Please accept the responsibility to review those results, and check that your registration number and qualifying points, as reported by the club, are correct. You can join the [www.NADACAgility@yahoo.com](http://www.NADACAgility@yahoo.com) list and set your settings to "no mail". You will be able to view trial results and check for any possible discrepancies, without receiving list mail. If you find an error in the reporting of your dog's qualifying points or registration number, please contact the host club. The host club is responsible for correcting any errors and informing NADAC. Levels: Points earned at a higher level of a class, prior to the completion of the lower level title, will not be banked by NADAC for future use. If a dog earns points in a level of a class that they are not eligible to title in, those points will not be added to the dog's records.

**I-83 to Exit 32** (Newberrytown Exit-old exit #13), Take Rt. 382 North to Lewisberry, approximately 3 miles to flashing traffic light. Turn left, on South Rt. 177 toward Rossville, travel approximately 3 miles. Turn right on Mt. Airy Rd. (across from Lake Pinchot Park Office) and continue 1.7 miles to site on left.

**AGREEMENT**

The person who signs this agreement represents that he/she is authorized to enter into this agreement on behalf of both exhibitor and the owner of entered dog. In consideration of acceptance of this entry:

1.1. As used here 'NADAC' means North American Dog Agility Council, Inc., its members, officers, directors, employees, show chairs, show committees and agents.

1.2. Exhibitor/owner, agree to abide by the rules and regulations of NADAC, and any other rules and regulations appearing in the premium for this event.

1.3. Exhibitor/owner certify that the entered dog is not a hazard to persons, dogs, or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the state in which the dog resides.

1.4. Exhibitor/owner acknowledge all hazards presented by the event and the event premises, including, but not limited to, the condition of the floors, stairways, halls, lighting, security measures or lack of, electrical appliances, fitting, show rings, parking areas and the presence of unfamiliar animals and people; exhibitor and owner assume the risk of any harm arising from these.

1.5. Exhibitor/owner release NADAC (including NADAC officers, directors, employees, and members), TNT Canines, (including its officers, directors, and members, and event organizing committee) Bella Vista training Center (including its officers, directions and members) In The Zone Agility (including its officers, directors, and members, and event organizing committee) and will defend them and hold them harmless from all present and future loss, injury, damage, claims, demands and liabilities involving the entered dog, the event or event premises. Without limiting the generality of the foregoing hold harmless provisions, exhibitor/owner hereby specifically assume sole responsibility for and agree to indemnify and save aforementioned parties harmless from any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damages because of bodily injuries, including death, at any time in consequence of my (our) participation in this event, howsoever such injury, or death may be caused, and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons.

Exhibitor understands there is a returned check fee of \$40.

THE MANAGEMENT will not be responsible for the loss or damage to any dog exhibited, or for the possessions of any exhibitor whether the result was by accident or any other cause. It is distinctly understood that every dog at this event is in the care and custody and control of his owner or handler during the entire time the dog is on the show premises. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Show Committee be asked to leave the show site. In such case, no refund of fees paid will be made.
