**From Washington, Northern VA and points South:**

From the Beltway, take I-270 to Frederick, and continue on North on US 15. Cross into Pennsylvania and continue north. Exit at RT 234 - 'Biglerville.' Go west on RT 234 towards Biglerville. Continue through Biglerville towards Arendtsville. At stop sign in Arendtsville, RT 234 continues towards right. Fairground is one mile further down RT 234 on right.

**From Harrisburg & points North and East:**

The easiest way is to get on the PA Turnpike(I-76) headed west. Get off at Exit 17 and go south on US Route 15 about 35 miles to exit at RT 234 - 'Biglerville.' Go west on RT 234 towards Biglerville. Continue through Biglerville towards Arendtsville. At stop sign in Arendtsville, RT 234 continues towards right. Fairground is one mile further down RT 234 on right.

**From Pittsburgh and points West:**

Take the PA Turnpike (I-76)East to the Blue Mountain Exit 15. Go south on PA Route 997 through beautiful countryside to US Route 30. Turn left on RT 30 and go over the mountain about 8 miles to blinking light at Cashtown. Turn left onto Cashtown road to Arendtsville. At stop sign in Arendtsville, RT 234 continues towards your left (North). Fairground is one mile further down RT 234 on right

**From Baltimore and Points Southeast:**

From the Beltway, take the Northwest Expressway past Owings Mills to the end and continue on MD Route 140 all the way through Westminster, Tanneytown, and Emmitsburg. in Emmitsburg, go North onto RT 15. 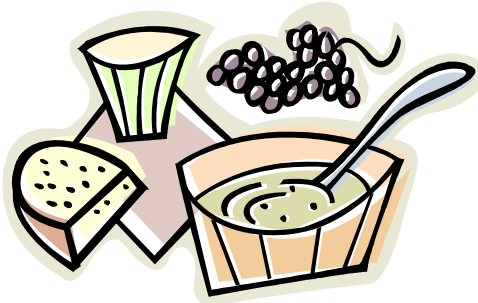

- All entries must be submitted on the current "Official UKC Entry Form". You may use one entry form to enter the same dog in more than one activity on the same weekend.
- Use a separate entry form for each dog entered in a club's event.
- Dog not UKC registered? Apply for a temporary Listing Number (TL) online at [www.ukc.org](http://www.ukc.org) or call the Dog Event Department at (203) 343-9020. (TL fees are non-refundable, non-transferable and do not apply to the cost of permanent registration.)
- All completed entry forms in the Event Secretary based under the event, unless otherwise specified.
- Obedience Trial, Agility Trial, Rally Obedience Trial, Weight Pull events and Dog Sport Trial events are open to all UKC registered breeds and mixed breed dogs with a valid Limited Privilege number.
- Obedience only. Check the box provided to request either the Veteran or Special Jump Height option. Veteran dogs must be 8 years or older. Eligible dogs for Special Jump Height are outlined in the current rules and regulations.
- Conformation classes consist of Puppy (6 mos., under 1 yr.), Junior (1 yr., under 2 yrs.), Senior (2 yrs., under 3 yrs.), Adult (3 yrs. and up); Breeder/Handler (6 mos. and up, handled by breeder or member of breeder's family); Novice Junior, Open Junior (8 yrs., under 19 yrs.), Novice Senior, Open Senior (19 yrs., under 18 yrs.); Champion, and Grand Champion.
- Junior Showmanship classes consist of Pee Wee (over 2 yrs., under 4 yrs.), Sub-Junior (4 yrs., under 6 yrs.), Adult (6 yrs. and up); Novice Junior, Open Junior (8 yrs., under 19 yrs.), Novice Senior, Open Senior (19 yrs., under 18 yrs.); Champion, and Grand Champion.

## We want you to keep the points earned at UKC Licensed events. Important things to remember:

- All dogs entering UKC events must be permanently registered, have a valid Temporary Listing Number, or a Limited Privilege number.
- All entry forms must be completed and signed. Incorrect information submitted on the entry form may invalidate your wins.
- To be eligible to enter into the Breeder/Handler class, you must be one of the breeders of record, or a member of the immediate family of one of the breeders of record. Immediate family includes: spouse, parent, step-parent, child, step-child, brother or sister.
