Due to the unprecedented times we are in—we have a few, hopefully temporary changes:

1. We will not be providing food, but we will be picking up food from a local sandwich and pizza shop. Details to will be provided later.
2. We are encouraging outside crating. We will have an airconditioned room available for those who need it. Masks and 6' spacing will be required in this this area.
3. The exhibition room will be limited to trial help, judge and one exhibitor only. We cannot allow ringside viewing for this trial. Exhibitors will enter, and leave immediately before and after run.
4. Walk throughs and familiarization will be at jump height, limited to two individuals on course at a time, and will be timed to ensure all can move through expediently.
5. Ribbons will be self serve.
6. Access to the secretary will be outside, and as needed only. We will post copies of the trial results outside.

We are not happy about these changes, but at least we will all get the opportunity to run our dogs.
